LOCATION

Manor Farm is located just 6.5 miles west of the town of Andover and less than 30 miles west of Basingstoke. Both towns have direct rail access to London. The farm has excellent road communication links with the A303 approximately 2 miles south of the property and the A338 approximately 3 miles west. Southampton airport lies approximately 32 miles south.

DESCRIPTION

Unit 2 at Kimpton Manor Farm is the last remaining unit available and is a smart, purpose built commercial unit, available as a whole. The building benefits from steel portal frame construction, concrete floors, roller shutter doors and 3-phase electrical connections. The building is well placed in a tidy concreted yard with a large turning circle for lorries and good onsite parking.

Unit 2 benefits from WC facilities and fibre broadband connections, along with a gas supply available for installation of a boiler.
